## Dear Gambier Islanders

We were delighted to receive your initial thoughts and positive replies to our April 19<sup>th</sup> email about our Rural Economic Diversification and Infrastructure Program (REDIP) grant.

We are reaching out again to share additional information about our project and ways Gambier Islanders can become involved.

## Project activities and timelines

Starting now through to May 2025 we plan as follows:

- Spring 2023 launch the project by appointing an oversight committee and recruiting volunteer/paid staff
- Summer 2023 develop and conduct a survey of island residents and property owners about community-identified priorities for the island\*
- Fall Winter 2023/2024 Review and compile the survey results and list the priorities for some plans to be developed and carried out\*
- Spring/Summer 2024 develop plans to address the most pressing priorities identified from the survey\*
- Summer 2024 to Spring 2025– begin activating some plans in order to begin addressing some priorities identified during the survey

\* We expect these activities to be completed with the assistance of a professional consultant.

## Ways to contribute to the project:

- Participate in the survey coming later this summer.
- Become a member of the Oversight Committee to provide overall leadership on this project. In order to successfully execute this project the Oversight Committee will be made up of various members of the Gambier Island community including two GICA board members. We are also seeking two or three people to represent the interests of other established Gambier Island organizations and two to three community-at-large members.
